This meeting was held immediately following the regular board meeting with all legislators present.

Legislator Sylor requested John Mancuso, Deputy Public Works Superintendent, to give an update on the County Wide Clean-up. Mr. Mancuso reported that the County has assisted 12 Towns and Villages and 3 additional municipalities have been scheduled. There are other municipalities who have conducted a Clean-up without requesting assistance from the County.

Discussion was held on the Towns need to be more stringent on the enforcement of "Junk Laws", with suggestions made to provide incentives to towns, businesses and individuals. Chairman Walchli requested that committee members bring any ideas they may have to Legislator Sylor, Chairman of the Public Works Committee.

James Mulholland, County Treasurer explained the process that he follows when making year end transfers. According to Generally Accepted Accounting Principles, the budget must be balanced when the books are closed and the resolution adopted at the end of each year approving these transfers, is the tool to do that. Mr. Mulholland explained the purpose of some of the transfers made to balance the 1998 Budget.

Discussion was held on the preparation of the 2000 Budget. It was suggested that the Board be given options to bring in a budget with a 0% increase. Reducing the size and scope of government was also discussed.

It was announced the some time possibly in July, 1999, there will be a "Government Exchange Day" with Wyoming County.

The Committee of the Whole will meet on July 8, 1999, for an Attorney Client Consultation on tax procedures.

There being no further business to discuss, the meeting was adjourned.
